Banking System Development Trends

The goal of the publication "Banking System Development Trends" is to analyze and assess the banking system of Kyrgyzstan as a financial intermediary, identify obstacles to achievement and maintenance of stability, as well as to estimate stability components of the banking system of Kyrgyzstan. It is published as of January 1 and July 1 of each year in Kyrgyz, Russian, and English.

The goal of a magazine "Statutory Acts of the National Bank of the Kyrgyz Republic" is to officially publish statutory acts of the National Bank to furnish the commercial banks and the public with the normative documents of the National Bank and to promulgate the banking legislation of the Kyrgyz Republic. Assumptive periodicity of the magazine is to publish it once a month in Kyrgyz and Russian.

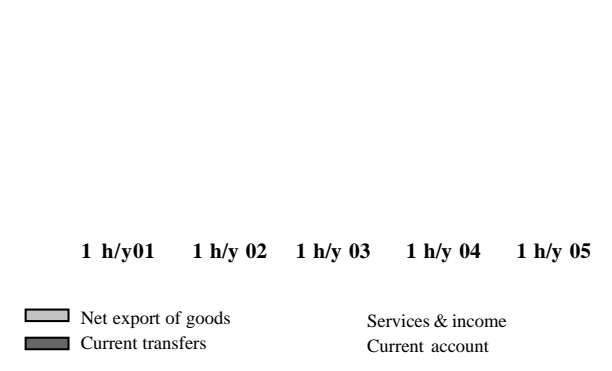

Current Balance of Payments Developments

The foreign trade turnover of the Kyrgyz Republic for the first half of 2005 amounted to US\$ 809.2 million against US\$ 750.3 million in 2004.

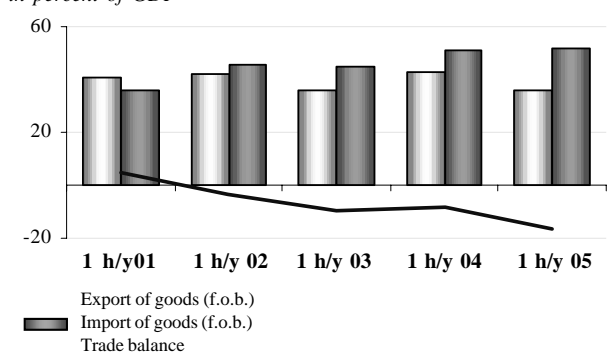
The current account deficit, characteristic of the first half of 2005, was equal to US\$ 73.9 million (4.2 percent of GDP) and increased by 46.2 percent as regards the same parameter in the corresponding period of 2004.

The deficit of balance of trade of US\$ 151.6 million in the first half of 2005, compared with a surplus of US\$ 4.7 million in the same period of 2004, is a result of the increase in the volume of imports of goods and services.

Having decreased by 4.1 percent in comparison with export in the comparable period of 2004, **export of goods** at f.o.b. prices developed at a level of US\$ 328.8 million.

The reduction of physical deliveries of gold by 21.7 percent was the primary factor of a decrease in export of goods. The decrease was not so significant in value terms, it was 16.4 percent and it speaks for the increase in the world prices of gold. It should be noted that the volume of exports of goods excluding gold increased by 5.4 percent and it is connected to the increased volume of deliveries of gasoline, cotton fiber, tobacco, glass, cement and vegetables.

Such positions in the functional structure of export, as export of energy products and consumer goods were observed to increase in January to June 2005, by 31.5 percent and 11.2 percent, correspondingly, in comparison with the similar period of the last year. This growth caused the increase in shares of these groups of goods by 3.3 percentage points. At the same time, export of non-capital goods was reduced by 14.2 percent due to the reduction of the volume of exports of gold. In addition, the decrease was observed in export of primary and investment goods by 12.2 and 5.8 percent, accordingly. The decrease in export of non-capital and primary goods was reflected in the reduction of their shares in the export turnover by 5.3 and 1.4 percentage points, accordingly. In addition, the share of investment goods remained unchanged and was 3.5 percent.

Despite the reduction of the share of non-CIS countries by 14.7 percent in the export turnover, still, it remains significant, having made 58.6 percent in the first half of 2005. Among the non-CIS countries, the United Arab Emirates (58.0 percent of export to the non-CIS countries), Switzerland (10.1 percent), Canada (9.9 percent), China (7.2 percent) and Turkey (2.5 percent) continue to remain basic consumers of Kyrgyz export. The deliveries of gasoline, incandescent lamps, and glass increased to the non-CIS countries.

Among the CIS countries, the largest trading partners in the period under review were Russia and Kazakhstan, whose joint share was 82.4 percent of total exports of CIS countries. Electricity, glass, cement, plastic products, mercury, tobacco, leather products, mineral waters and drinks were basic items of export to these countries.

Based on the results of the accounting period, **import of goods**¹ at f.o.b. prices increased as against the base period by 17.9 percent and amounted to US\$ 480.4 million.

In the first half of 2005 the volume of imports was observed to grow by all functional groups of goods, except for primary goods. The consumer goods and energy products became the largest import items - their weights amounted to 32.1 percent and 27.5 percent, correspondingly. At the same time, import of investment goods increased considerably - by 38.4 percent - and these were, mainly, machines and equipment, household appliances, and lorries. The share of investment goods amounted to 18.7 percent and it was more than the volume of the last year for the corresponding period by 3 percentage points. The volume of imported consumer goods increased by 9.7 percent, basically, of such goods, as fabrics, beer, detergents, and printed matter. Import of non-capital goods, such as chemicals, rubber tires, paints and varnishes, mineral fertilizers, cast iron and steel products increased by 18.5 percent and amounted to 16.8 percent of the import turnover, being by 0.4 percentage points more in comparison with the corresponding period of the last year. At the same time, import of primary products was considerably reduced (by 21.1 percent) and it had its impact on the reduction of the share of primary goods by 2.3 percentage points and was 4.9 percent.

The share of CIS countries prevailed in the geographical structure of Kyrgyz import - it was 60.4 percent. Russia was the largest partner in imports among the CIS countries in the first half of the year (49.0 percent of the import turnover from the CIS countries). Against the decrease in imports from Kazakhstan (by 18.0 percent), growth of imports was observed from Russia (by 19.0 percent), Uzbekistan (by 26.5 percent), Ukraine (2.4 times) and Turkmenistan (28 times). From these countries imported were, basically, chemicals, rubber tires, asbestos, mineral fertilizers, and cast iron and steel products.

Among the non-CIS countries the largest shares was that of the USA (21.2 percent of the volume of imports from the non-CIS countries), China (16.5

percent) and Germany (10.4 percent). Electricity distributing equipment, machines and equipment for civil construction, aluminum, steel products, engines, plastics, paper and cardboard were, mainly, imported from the European countries. The Asian countries delivered inorganic chemicals, cast iron and steel products, machines for data processing, and artificial fabrics, while America delivered machines and equipment for civil construction, electricity distributing equipment, steel and iron products, polymers, and lubricants.

For the first half of 2005 **the balance of services** was negative and amounted to US\$ 23.5 million as a result of the increase in import of services by 38.8 percent, with export of services having increased only by 18.5 percent.

In the first half of 2005 export of services amounted to US\$111.9 million. The largest shares in export of services were those of such items as "Trips" and "Transportation Services", which made in the aggregate 55.7 percent of the export turnover. Export of transportation services grew by 23.4 percent, while the item of "Trips" showed the decrease in the volume of these services by 9.7 percent. The remaining 44.3 percent of export services represented the significant shares of business, construction and governmental services. It is necessary to note sharp growth (3 times) of exports of construction services to the CIS countries.

The volume of import of services grew by 38.9 percent in the accounting period and amounted to US\$ 135.4 million. Transportation services, whose volume increased 1.5 times in comparison with the basic period, prevailed in the structure of import. "Business services" and "Other Services" together with the item "Trips" were the large items of import. The volume of business services increased 1.5 times, other services - 3.6 times, with the total value of these two items amounting to US\$ 22.3 million.

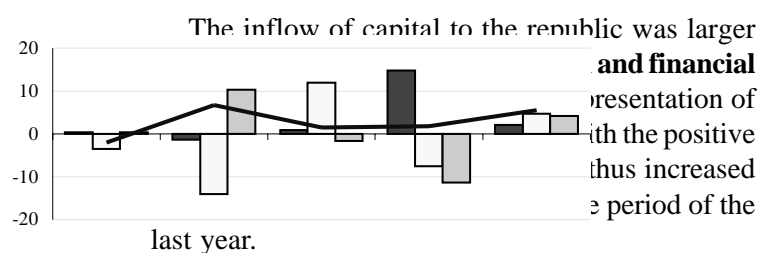
¹ Import at c.i.f. prices totaled US\$ 518.9 million in the 1st half 2005, with the trade gap being US\$ 190.1 million.

The outcome of the first half of 2005 indicated the negative **balance of income** of US\$ 46.5 million, having decreased by 17.9 percent as against the comparable period of the last year. At the same time, the negative balance of income from direct and other investment was observed to decrease.

The share of income from direct investments was 50.0 percent of the total volume of the balance of income, having decreased as against the base period by 27.5 percent and it speaks for growth of reinvested income.

The volume of wages paid to non-residents, temporarily working in the Kyrgyz economy, increased by 41.7 percent.

In the 1st half of 2005 a net inflow of private transfers increased up to US\$ 140.3 million and it is 2.2 times more than in the 1st half of 2004. The last fact is due to, mainly, the increase in the inflow of cash resources from labor migrants. At the same time, the volume of official transfers decreased by 19.6 percent and amounted to US\$ 7.4 million. As a whole, according to the developments, the **balance of current transfers** was positive.

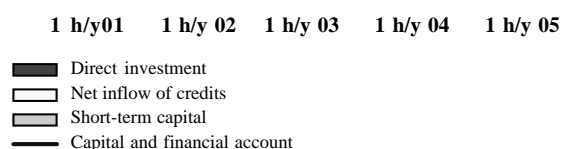


In addition, the deficit of **the capital account** for the accounting half of the year increased 2.3 times in comparison with the comparable period of the last year in and totaled US\$12.1 million. It is necessary to note growth of the outflow of assets of migrants by 39.0 percent in comparison with the corresponding period of the last year.

Judging the results of the first half of 2005, **the financial account** had the positive balance of US\$ 62.9 million and it is 3.1 times more than in the first half of the last year.

The net inflow of **direct investment** was reduced 6.2 times and amounted to US\$ 19.1 million. Such a significant difference speaks for the inflow of sales proceeds of Kyrgyz shares in a foreign company in the 1st half of the last year. This year, the inflow of capital in ownership capital of enterprises totaled US\$ 4.4 million. The value of income reinvested in the economy of the republic decreased by 29.4 percent and amounted to US\$ 21.4 million. Direct investments were made, basically, in industry and in the financial sector. In the case of direct investment, transactions of large enterprises continued to play a determining role.

The net outflow of **portfolio investments** for the accounting period amounted to US\$ 12.0 million. The cardinally different situation in this area was observed in the 1st half of the last year: there was the net inflow of US\$ 8.1 million.

The balance of **other investments** in the first half of the current year increased 2.5 times in comparison with the last period and developed with the positive value of US\$ 55.8 million. Its value resulted from the decrease in foreign assets of residents of the Kyrgyz Republic with substantial growth of their foreign liabilities.

The reduction of foreign assets was caused by, basically, the reduction of assets of commercial banks, which was, substantially, due to the decrease in the foreign assets on the accounts of banks abroad (correspondent accounts - nostro).

The net inflow of total liabilities on other investment increased as against the base period by US\$ 71.7

million and totaled US\$ 73.3 million. Growth of this parameter was due to the increased cash receipts under the items "Cash and Deposits" - US\$ 35.5 million; "Short-term Credits" - by US\$ 33.5 million. In addition, the essential increase in the accounting period was partly related to an improved procedure of data collection and processing with respect to the transactions of commercial banks and, as a consequence, better coverage and quality of statistics on "Other Investment".

The item "**Errors and Omissions**" had the positive balance in the first half of 2005 and amounted to US\$ 1.6 million.

So, for the first half of 2005 the total balance of payments was negative and accounted to US\$ 21.5 million.

Total international reserves of the NBKR were US\$ 541.4 million at the end of accounting period and it corresponds to 5.3 months of import of goods and services.

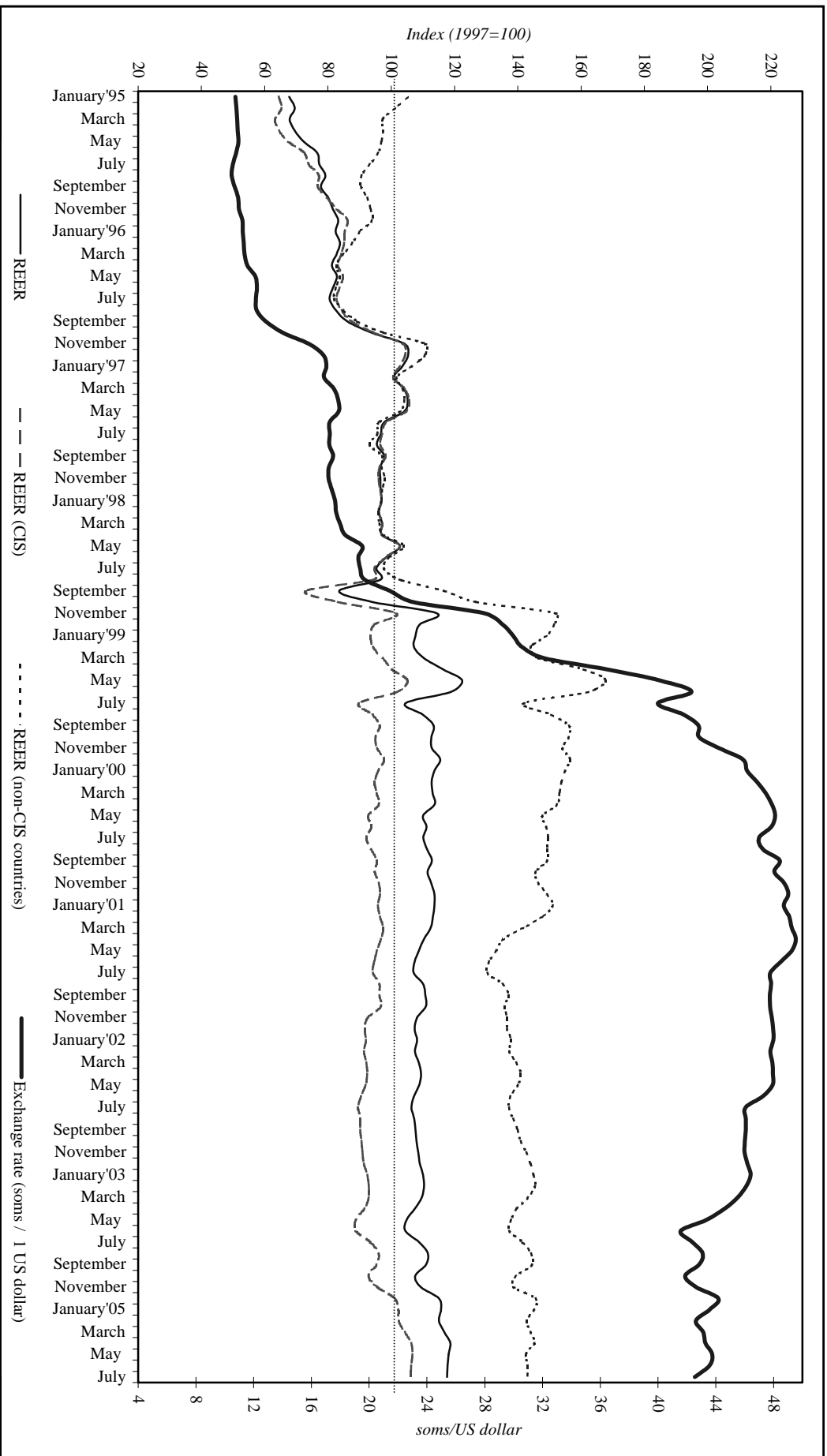
